Terms & Conditions

THIS AGREEMENT is made on the date of signing as specified on the booking form between **Whiteline Limos**, the vehicle owner, and the person named on the booking form.

It is hereby agreed.

Whiteline Limos will hire to the hirer the vehicle(s) as described on the booking form. On the date as described on the booking form, at the time described on the booking form and for the purpose of the journey as described on the booking form.

The hirer agrees to pay a minimum of 50% as a deposit to secure the booking.

Whiteline Limos will confirm to total charge and thereby the deposit on first contact. The hirer should be aware that the deposit or any other monies paid are non-returnable. Please note that this booking will not be confirmed until a deposit has been received.

The hirer must pay the balance due (if any) of the hire charges no later than one week prior to the hire date as specified on the booking form. Failure to pay any balance due on time may result in the booking being cancelled without further notification and any deposit paid will be forfeited.

In the unlikely event that the vehicle(s) are unavailable for any reason, or the vehicle(s) breaking down immediately prior to, or on the date of hire, then a suitable replacement vehicle will be provided by **Whiteline Limos** and shall be accepted by the hirer, our priority being to ensure that you arrive at your event by whatever means available to us.

The hirer agrees to compensate **Whiteline Limos** for any loss arising from or damage to any vehicle that **Whiteline Limos** hires to the hirer, whether caused by the hirer, or any of the passengers carried on behalf of the hirer. This includes, but is not limited to damage to glassware, fixtures and fittings of the vehicle and fouling. In case of fouling a standard charge of £150 shall be charged to the hirer and will be payable immediately. The hirer may also be liable for any loss of subsequent revenue resulting from damage (including fouling) to the vehicle.

Whiteline Limos will ensure that the driver will do everything with their power to arrive at the collection and subsequent destination at the times stated on the booking form. However, neither **Whiteline Limos** or the driver at the time of hire can accept any responsibility for late arrival or delays caused by any event which is beyond our reasonable control or by any unforeseen circumstances or problems that arise.

Whiteline Limos comply fully with the licencing requirements of South Gloucestershire Council, Bristol City Council and North Somerset Council.
